AN ORDINANCE LEVYING TAXES FOR THE PARK DISTRICT OF FOREST PARK, COUNTY OF COOK AND STATE OF ILLINOIS FOR THE YEAR 2024

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE PARK DISTRICT OF FOREST PARK, COOK COUNTY, ILLINOIS:

SECTION I. That the sum of THREE MILLION SIX HUNDRED FORTY THOUSAND FOUR HUNDRED SEVENTY-FOUR (\$3,640,474.00), or so much as may be authorized by law, is hereby assessed and levied for the anticipated objects and purposes specified below, on all taxable property within the Corporate limits of the Park District of Forest Park at full, fair cash value as the same is assessed and equalized for State and County purposes for 2024.
